First Party: -

 Visakhapatnam for faculty & students at a time both the parties agree to,
 without any findncial commitment.
- 2) The College shall make arrangements for the organization of Exhibitions / Field Works to Department of Horticulture, Andhra University Visakhapatnam as part of their curriculum.
- 3) The College shall make arrangements for the students to carry out project works / dissertations / research work under the guidance of scientists/officers of Department of Horticulture, Andhra University, Visakhapatnam without any financial commitment.
- 4) The College shall provide expertise of the staff to act as Resource Persons in on-campus training sessions in the college as part of knowledge-sharing basis without any impediment to their normal, regular duties.

Second Party:-

- 1) Department of Horticulture, Andhra University, Visakhapatnam may arrange expert lectures, project demonstration, and seminars in the premises of college or at the O/o Department of Horticulture, Andhra University, Visakhapatnam without any financial commitment by both parties.
- 2) Department of Horticulture, Andhra University, Visakhapatnam may conduct Workshops / Seminars / Conferences / Exhibition for faculty

The College and Department of Horticulture, Andhra University, Visakhapatnam agree not to disclose or discuss details of this MoU to others at any point of time.


VALIDITY
