MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding is entered on 9th MAY, 2022 between Dr. V.S.KRISHNA GOVERNMENT DEGREE & PG COLLEGE (A) having its office at Maddilapalem, Visakhapatnam 530013 hereinafter " College" or "First party" which expression shall where the context so admit include its successors and permitted assignees.

INDIA YOUTH FOR SOCIETY(IYFS), an organization, post@iyfs.in, Webpage http://iyfs.in a nongovernment organization, having its office at D.No. 9-26-4 FF, Paila Mansions, C. B. M. Compound, Visakhapatnam, Pin - 500003 (Andhra Pradesh-India), hereafter called "INDIA YOUTH FOR SOCIETY(IYFS) " or "second party" which expression shall where the context so admits include its successors and permitted assignees. 1

Whereas INDIA YOUTH FOR SOCIETY was established under the Andhra Pradesh Societies Registration Act, 2001 (Regd.No.331/2011) with headquarters at Visakhapatnam. The society runs its awareness campaigns in Visakhapatnam as well as Hyderabad. It has been affiliated to Nehru Yuva Kendra, United Nations Environment Programme (UNEP), United Nations Framework Conservation on Climate Change (UNFCCC), Oceans Conference and Global Waste Cleaning Network. Objectives of the society are teaching about conservation methods, to spread environmental awareness, to implement plastic pollution preventive measures, to work towards water conservation, to help unemployed youth with mentorship and assistance, to promote traffic safety, to aid in drug de-addiction and provide mental support and encourage handicrafts and promote local heritage.

RESPONSIBILITIES:

First Party:

- (1). The college makes arrangements for conducting workshops and seminars to India Youth to sensitize students towards environment and nature protection.
- (2). To facilitate students to rallies, awareness campaigns, cleaning of beach and collection of used plastics & polyethylene through student activities.
- (3). The college shall provide expertise of the staff to act as resource person to conduct awareness camps at various educational institutions and public places.
- (4). The college provide students for taking training programs in making Cloth bags, Paper bags and jute bags.
- (5) The college provides students for learn and manage the collection of plastics & polyethylene covers and send them to Recycling units.
- (6) The college students collect the plastic and polyethylene, used plastic ball point pens, dry & wet wastes and broken glassware and handed over it for India Youth for Society vehicles.

Second Party:

- (1). IYSF conducts lectures, awareness campaigns and training programs for the students.
- (2). IYSF organizes rallies for mass awareness on issues related to environment and nature.
- (3). IYSF conducting elocutions and debate competitions on nature and environmental issues among the students.
- (4). IYSF sensitizing students on Plastic free India
- (5). IYSF raising awareness on clear coasts campaigns.
- (6). IYSF helps the students in recognize industries that have a demand for manpower. It then facilitates training programs to up skill the unemployed population and provide them with jobs.

(7). IYSF provides part time or house hold earnings by way of collection of plastic at doorsteps, collection of scrape in streets and honorarium to conduct awareness campaigns among the local areas.

DELIVERY

- 1). The mode of training will be offline or online.
- 2). Training offered:
 - a) Providing of recycling units
 - b) making of jute bags, cloth bags and paper bags.
 - c) Setting up rain harvesting pits (RHP)
 - d) Conducting field trips for Identification, collection and segregation of plastics & polyethylene.

CONFIDENTIALITY

The COLLEGE and India Youth For Society agree not to disclose or discuss details of this MOU to other at any point of time.

OWNERSHIP OF WORK

During the tenure of this agreement, the intellectual rights for any work of content created/ provided by India Youth For Society will be reserved with India Youth For Society and the college however both the parties will be allowed to use the content for academic purpose during training programs, seminars or seminar activity organized incollaboration.

VALIDITY

The MOU shall be valid, initially for a period of 5 years extendable by mutual consent and the MOU may be withdrawn at any time unconditionally by either of the parties with a prior notice of one month.

SETTLEMENT OF DISPUTES

The parties shall put their best efforts to settle amicably all disputes arising out of or in connection with this agreement or the interpretation thereof. If any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with construction, meaning operation, effect interpretation of the agreement or breach thereof which parties or unable to settle mutually within 30 days from the commencement of settlement proceedings and if not settled then the same shall be referred to the court of Andhra Pradesh Jurisdiction.

TERMINATION:

The MOU may be terminated on expiry of the stipulated period or by giving a notice of one month or the conclusion of ongoing programs, whichever is later, from either side. This memorandum which is in 04 pages is signed on 09 May 2022 and exchanged on 09 May 2022.
