India, hereafter called "Green climate" or "second party" which expression shall where the context so admits include its successors and permitted assignees.

Whereas Green Climate Team rises environmental and Natural issues to the public and also brings it to the notice of the government through its magazine "GREEN CLIMATE". It strives also conducts awareness camps in various educational institutes in and around the north coastal districts of Andhra Pradesh. It strives, also involves in plantation programs, to increase the population of birds and animals, promotes collection of used plastics for recycling, encouraging arrangements of water harvest pits in Urban centers, offices and educational institutions and awareness on environmental pollution aspects.

### **RESPONSIBILITIES:**

#### **First Party:**

- (1). The college makes arrangements for conducting workshops and seminars to green climate team to sensitize students towards environment and nature protection.
- (2). To facilitate students to rallies, awareness campaigns, cleaning of beach, collection of used plastics & polyethylene and mass & avenue plantation programs through student activities.
- (3). The college shall provide expertise of the staff to act as resource person to conduct awareness camps at various educational institutions and public places.

#### **Second Party:**

- (1). Green Climate Team conducts lectures, awareness campaigns and training programs for the students.
- (2). Green Climate Team organizes beach cleaning, plantation programs, rallies for mass awareness on issues related to environment and nature.
- (3). Green Climate Team conducting elocutions, debates and drawing competitions on nature and environmental issues among the students.
- (4). Green Climate Team conducting awareness on identification of the local plant varieties which are suitable and sustainable for mass and avenue plantation.
- (5). Green Climate Team helps the students to identify, collect and grow the medicinal plant species to understand the process of pharmacognacy.

### **DELIVERY**

- 1). The mode of training will be offline/online.

2). Training offered:

a) Preparation of Nurseries

b) Weaving of bird nests.

C) Setting up Rain Harvesting Pits (RHP)

d) Conducting field trips for Identification, collection and cultivation of medicinal plants.

e) Procedure, how to collect used plastics & recycle,

### **CONFIDENTIALITY**

The COLLEGE and GREEN CLIMATE TEAM agree not to disclose or discuss details of this MOU to other at any point of time.

### **OWNERSHIP OF WORK**

During the tenure of this agreement, the intellectual rights for any work of content created/ provided by green climate team will be reserved with Green climate team and the college however both the parties will be allowed to use the content for academic purpose during training programs, seminars or seminar activity organized in collaboration.

### **VALIDITY**

The MOU shall be valid, initially for a period of 3 years extendable by mutual consent and the MOU may be withdrawn at any time unconditionally by either of the parties with a prior notice of one month.

### **SETTLEMENT OF DISPUTES**

The parties shall put their best efforts to settle amicably all disputes arising out of or in connection with this agreement or the interpretation thereof. If any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with construction, meaning operation, effect interpretation of the agreement or breach thereof which parties or unable to settle mutually within 30 days from the commencement of settlement proceedings and if not settled then the same shall be referred to the court of Andhra Pradesh Jurisdiction.


## TERMINATION:

The MOU may be terminated on expiry of the stipulated period or by giving a notice of one month or the conclusion of ongoing programs, whichever is later, from either side. This memorandum which is in 04 pages is signed on 27/04/2022 and exchanged on 27/04/2022.




